The problems we face in healthcare is because of lack of insight from the government, and not from lack of verbalization of members. The government has disrespected us to tasks. Ontario has the worst nurse:patient ratios in the country, and it's worsening with a growing nursing shortage. The Ontario government is not managing this growing concern. As healthcare professionals, we have taken that burden on by working harder and longer. We need to hold the employers accountable. Members should be paid for all worked hours and not feel intimidated by the employer for missed breaks or work beyond their shift. I want members to be empowered because they belong to a collective and be able to stand up for their employee right of overtime. We need to improve union presence in the work environment. It is essential in the Bargaining Units to protect and empower members. It holds employers accountable for poor work environments, and increased workloads.

Members dues money should go back towards the members. Members money that supports non-profit organizations should be filter back to the Locals to help support members in their bargaining units to improve members work environment and enforce the collective agreement.

2. ONA Accountability: More Transparency to the members.

Members direct their views and opinions to their Local, and their Bargaining Unit on voting of the ONA Constitutions, on fiscal budgets and Local policies. Local members need to be made aware of all activities of their Local via all means possible. In my opinion, there are Locals within ONA where the Local Executives develop policies and pass these policies without the membership knowledge or participation; these Locals cite members "don't come to meetings." It is the Local's responsibility to do their due diligence to communicate the Local's activities, as well as ONA Centrals activities.

The ONA Constitution is a legal contract between ONA and its members. The ONA Constitution is to reflect the will of the members by all means possible. We need Local Coordinator accountability demonstrating members involvement in voting delegation on changes or amendments to the ONA Constitution.

3. Union Rights are Human Rights.

I have a strong opinion on Diversity, Inclusivity, and Equity (DEI). My parents immigrated to Canada. I am first generation Canadian. My family experienced oppression and discrimination. I personnel fought through these experiences and still fight for those oppressed and discriminated by others.
