Candidates will be advised as to the date that email content must be provided to the CEO in order to be included in the email to ONA membership.

We will also be scheduling and recording a virtual Meet the Candidates session where members can hear directly from candidates about their perspectives, positions and plans. More information on the date and time for this session will be provided in the near future.
